



CODE OF CONDUCT

We offer class and school-wide positive behavior support implemented through School-Wide Behavior Expectations posted throughout the building. The school-wide rules are centered around the Big 3: Be Respectful, Be responsible, and Be safe. In our classrooms, the expectation is:

1. Follow adult directions right away
2. KYHFOOTY- Keep Your Hands, Feet, and Other Objects to Yourself.
3. Use kind words and actions

Students are rewarded for following school expectations by:

- Students feel safer and have a more enjoyable time at school.
- Students get a better education and help others do the same.
- Students feel good about themselves and the choices they are making at school.
- Mountain Man Tickets - can be given to students by all members of the Oquirrh Faculty. Students can turn their tickets in for a small prize on Fridays. They are also given individual awards for above and beyond positive behavior throughout the school.
- Individual classroom awards and student recognition on a class by class basis.
- A Peak Power program which rewards classes for appropriate whole class behavior in common areas, including the lunchroom.

Discipline Procedures

A relationship-centered approach to problem-solving will be used with all disciplinary actions at Oquirrh Elementary. Students, parents and teachers will be included as part of the team to problem solve, teach replacement behaviors and support changes. Students will be encouraged to use the wellness room to relieve stress, decompress when they feel anxious or need a break to prevent an escalation of behaviors. Consequences for student misbehavior focus on learning and are applied in a fair and consistent manner, respecting individual rights, responsibilities, ability, needs, age and maturity.

Consequences for not following school expectations include:

- Individual warnings
- Opportunities to reflect and think about changing behavior
- Natural consequences such as helping clean, missing a few minutes or all of recess, and losing privileges
- THINK Time in another classroom
- Conference with teacher, parents, administration
- In-School Suspension
- Out-of-School Suspension

At Oquirrh Elementary, we are particularly concerned about ensuring the safety of each student. Students that commit repeated acts of verbal intimidation, cyber intimidation or physical aggression may also be referred to a District Safe Schools Hearing or to the Jordan Family Education Center for anger management or other recommended classes. Severe acts of aggression may result in immediate suspension to a District Level Hearing.

Bullying

- Students and staff at Oquirrh Elementary have the right and privilege to work in a bully-free environment.
- Bullying is defined as “aggressive behavior that is intentional and involves an imbalance of power or strength.” It is on-purpose, one-sided, and repeated. Types of bullying include: (1) physical bullying--i.e. hitting and/or punching; (2) verbal bullying-- teasing or name calling; (3) non-verbal or emotional bullying-- intimidation through gestures, social exclusion and relational aggression; and (4) cyberbullying-- sending insulting, threatening, or harassing messages by phone, computer, or electronic messaging.
- A student is being bullied or victimized when he or she is exposed, repeatedly and over time, to negative actions on the part of one or more students. See District Policy AS98 - Bullying and Cyberbullying.

To prevent bullying at Oquirrh Elementary:

- Anti-Bullying training will be provided to teachers, instructional assistants, and students using a district approved social/emotional skill building program. These social skills lessons are taught to each grade level.
- There will be designated “Morning Meetings” that occur in every classroom, and include lessons on bullying, inclusion, self-care, emotions regulation, positive self image, friendship and other topics. Meetings are intended to create unity and team building in classrooms and reduce incidents of bullying and other negative behaviors towards peers.
- Students will learn how to recognize bullying, report it, and solve problems in a positive, productive way. Students will also be encouraged and reinforced for kindness through varying kindness initiatives throughout the year. At Oquirrh Elementary, we are working to develop the trait of kindness in all students.
- Students are instructed to accurately report bullying to teachers, instructional assistants, playground aides, and/or school administration as soon as it happens so that it can be resolved.
- If a student reports bullying, school staff will discuss the issue with the students involved and will contact school administration as needed. School administration will contact parents involved and will determine a plan to prevent bullying. In-school or out-of-school suspension will be considered depending on the frequency, intensity and severity of the incidents, so as to create a safe, productive environment for all students.

Cell Phones and All Other Electronic Devices

- Possession of a cell phone, or a smartwatch by a student is a privilege that may be forfeited by any student that uses his/her cell phone/smartwatch inappropriately. A student who possesses a cell phone/smart watch shall assume responsibility for its care. At no time shall the District be responsible for preventing theft, loss or damage to cell phones/smart watches brought onto school property. Cell phone / smart watch use during classroom time, recess, instructional activities and field trips is prohibited. Cell phones must be **put away** during these times. Exceptions to this policy may be granted by school administration on a

case-by-case basis to accommodate family emergencies or medical necessity. Students violating these guidelines will be disciplined in accordance with District Policy AS67 - Discipline of Students (<http://policy.jordandistrict.org/as067/>).

- Any use of an electronic device that exploits personal information, disrupts the educational process, invades personal privacy or compromises the integrity for educational programs is strictly prohibited. Students in violation will be disciplined in accordance with District Policy AS67 - Discipline of Students (<http://policy.jordandistrict.org/as067/>). Photographs and/or videos are not to be taken of any person using such devices.

Dress Code – (Jordan School District Policy AA419)

- Clothing should be clean and in good repair.
- Gang-related clothing of any kind is not allowed.
- Clothing that depicts violence, use of drugs, alcohol, or other inappropriate slogans are not allowed.
- Footwear, appropriate for the day's activities, shall be worn at all times.
- Hats and other headwear may be worn unless it disrupts the school or activity, poses a danger to self or others, or limits the ability to identify the student. Any headwear that does not allow the student's face to be visible is not allowed.
- Any dress or appearance item or practice that creates an unhealthy, unsafe, or disruption to the school or school activity may be prohibited.
- Oquirrh follows the dress and appearance standards outlined by the Board of Education. The following document outlines appropriate and inappropriate clothing choices, and can also be viewed at this link:

Student Conduct, Dress & Appearance Guidelines

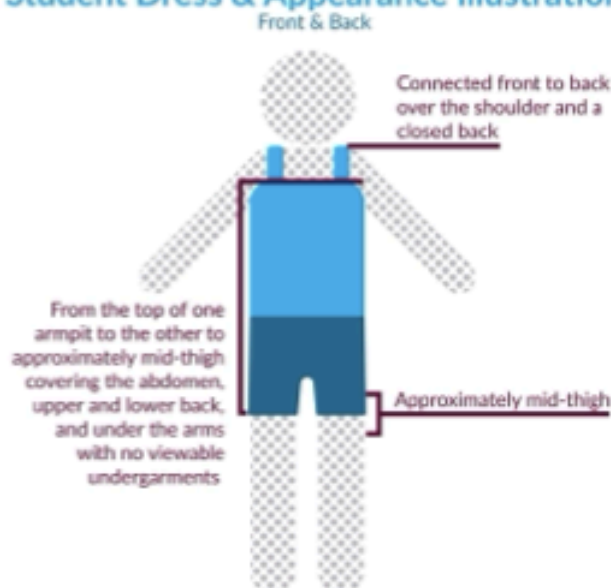
School administrators are responsible for the implementation and enforcement of student conduct, dress and appearance standards contained in District policy [AA419-Student Conduct, Dress, and Appearance](#) and these guidelines. The legal concept of "reasonableness" shall be the guiding principle in the application and discipline of student conduct, dress and appearance. Adherence to the conduct, dress, and appearance standards and these guidelines will be the responsibility of the student and their parent(s)/guardian(s). School administrators will have final judgement on all matters concerning interpretation of student conduct, dress, and appearance.

The following specific guidelines have been established to aid students, parents, staff and administration in the implementation and enforcement of policy [AA419-Student Conduct, Dress, and Appearance](#):

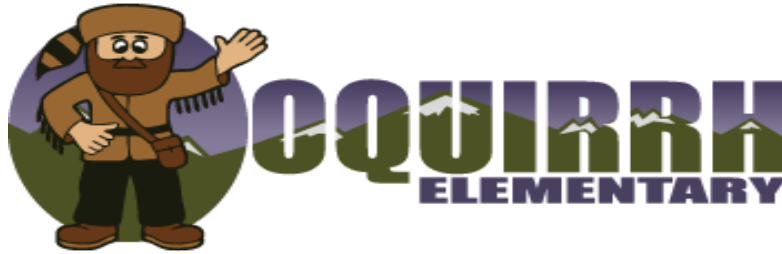
Dress and Appearance Standards include (but are not limited to) the following:

1. Clothing should be clean and in good repair.
2. Hats and other headwear:
 - a. May be worn unless it disrupts the school or school activity, poses a danger to self or others, or limits the ability of others to identify the student.
 - b. Any headwear that does not allow the student's face to be visible is not allowed.
3. Clothing (See figure):
 - a. Must cover from the top of the armpit to approximately mid-thigh with no viewable undergarments (waistbands and bra straps excluded).
 - b. Must be from the top of one armpit to another and connected from the front to back over the shoulder, have fabric in the front (covering the abdomen), on the sides (under the arms), and have a closed back (covering the upper and lower back).
 - c. Provide coverage of the buttocks, genitals, and chest with a fabric that is not see-through.
4. Clothing, appearance, jewelry, accessory, footwear, or personal item shall be free of any writing, images, symbols, or any other insignias that:
 - a. Are lewd, vulgar, profane, obscene, or sexually suggestive.
 - b. Advocates, represents, or promotes racism, discrimination, violence or hate in any form.
 - c. Signifies or depicts gangs and/or illegal or criminal activities. (Administrators in consultation with law enforcement agencies will determine what signifies and/or depicts these activities.)
 - d. Shows or references tobacco, alcohol, drugs, or any illegal substance.
5. Except as a part of an approved school activity or medical reasons, sunglasses may not be worn in school during the school day.
6. Footwear, appropriate for the day's activities, shall be worn at all times.
7. Any dress or appearance item or practice that creates an unhealthy, unsafe, or disruption to the school or school activity may be prohibited.
